

Based on the General Provisions of the GAA of 2020, Section 60: Cash Budgeting System, all appropriations shall be made available for release and disbursement for the purpose specified and under the same general and special provisions applicable until December 31, 2020. The appropriation for infrastructure capital outlays shall be valid for obligation until December 31, 2020 while completion of the construction, inspection and payments shall be made not later than December 31, 2021. Appropriation for MMOE and other capital outlay items shall likewise be valid for obligation until December 31, 2020 while the delivery, inspection, and payment or disbursement shall be made not later than June 30, 2021.

Therefore, request(s) for payment with complete documents shall be made in writing not later than (NLT) than the dates indicated above accompanied by an invoice describing, as appropriate, the Goods delivered and/or Services performed or Works done, with the documents submitted pursuant to the SCC provision and upon fulfillment of other obligations stipulated in the conditions for the procurement and in the Contract.
