**RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT FOR THE
PROCUREMENT OF FOLDABLE BICYCLE
SVP NO. 2021-013**

WHEREAS, the Central Office Bids and Awards Committee (COBAC) – D received the Purchase Request (PR) from the Health Emergency Management Bureau (HEMB) for the Procurement of Foldable Bicycle in accordance with Republic Act (RA) 9184 and its 2016 Revised Implementing Rules and Regulations (IRR) through the General Appropriations Act of 2021 with a Total Approved Budget for the Contract (ABC) of Four Hundred Thousand Philippine Pesos (Php400,000.00):

WHEREAS, COBAC Resolution No. 2021-130 “Recommending Approval for the Use of Negotiated Procurement through Small Value Modality for the Procurement of Foldable Bicycle under SVP No. 2021-013” was approved;

WHEREAS, on 05 March 2021, the Request for Quotation (RFQ) was posted in the PhilGEPS and DOH websites and in conspicuous places within the premises of the Department of Health (DOH) for a continuous period of three (3) calendar days;

WHEREAS, the RFQ was sent to three (3) prospective bidders listed below:

1. Biotech Solutions and Medical Supplies Trading (BSMST);
2. Pharmastar Int’l Trading Corp.(PITC); and
3. Royal Tree Int’l Trading Corp. (RTITC)

WHEREAS, pursuant to Annex “H” Section (V) (D) (8) (b) (ii), the BAC shall prepare and send RFQs to at least three (3) suppliers. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;

WHEREAS, the Technical Working Group (TWG) was created through the issuance of Department Personnel Order (DPO) COBAC No. 2021-082 dated 05 March 2021;

WHEREAS, on 09 March 2021, the Submission and Opening of Quotations took place as scheduled at 9:00 A.M. at the COBAC Conference Room, Ground Floor, Bldg. 6, DOH and through Cisco Webex;

WHEREAS, three (3) bidders submitted their respective proposals, namely:

1. Bacolod Elkan Trading Inc. (BETC);
2. PITC; and
3. Avecilla Trading (AT)

WHEREAS, the envelopes containing the eligibility and technical documents were opened and the presence and validity of all the required documents were verified by the COBAC-D in the presence of the prospective bidders representatives. Upon checking, all bidders were declared “ELIGIBLE and PASSED” and their quotations were read out publicly and posted in the Abstract of Quotations, to wit:

WHEREAS, PITC was declared as a lowest bidder as read subject to further arithmetical review and correction of the financial bid to determine the bonafide Lowest Calculated Quotation (LCQ);

WHEREAS, on 10 March 2021, the detailed evaluation of the legal, financial and technical aspects of the submitted proposal of PITC was undertaken by the designated TWG;

WHEREAS, the TWG-Financial Evaluator submitted the Abstract of Bid as Calculated, to wit:

WHEREAS, on 12 March 2021, the TWG-Financial, Legal, and Technical found PITC “Complying” on the requirements and submitted their respective reports;

WHEREAS, on 16 March 2021, the above-cited TWG report was presented to the COBAC-D during its 20th Regular Meeting. The Committee upon review and deliberation, concurred with the TWG recommendation and recommended the award of contract to the LCQ namely, PITC;

WHEREAS, at the time of the signing of this resolution, there is no pending Request for Reconsideration (RfR), no pending Protest and the COBAC-D followed the requirements set forth in R.A. 9184;


NOW THEREFORE, on the basis of the above, the herein members of the COBAC-D **HEREBY RESOLVE** to recommend the award of contract to **Pharmastar Int'l Trading Corp. (PITC)** determined as the Lowest Calculated and Responsive Quotation with a Total Contract Price of **Three Hundred Forty Thousand Philippine Pesos (PhP340,000.00)** inclusive of other taxes for the item listed below:
