SO THE PUBLIC MAY KNOW:

THIS AGREEMENT made the _____ day of 09 OCT 2020 between the **DEPARTMENT OF HEALTH (DOH)** of the Republic of the Philippines, as represented by **DR. NAPOLEON L. AREVALO, Director IV, Disease Prevention and Control Bureau**, with official address at San Lazaro Compound, Rizal Avenue, Sta. Cruz, 1003 Manila (hereinafter called "the Entity") of the one part;

-AND-

ALOG and Company, Inc. as represented by **MR. JOHN VINCENT CANDOL, Sales Coordinator**, with official address at Unit 301, Alabang Business Tower, 1216 Madrigal Business Park, Alabang, Muntinlupa (herein after called the "SUPPLIER") of the other part.
