THIS AGREEMENT made the _____ day of _____ 20____ between the **DEPARTMENT OF HEALTH (DOH)** of the Republic of the Philippines, as represented by **DR. FRANCISCO T. DUQUE III, Secretary of Health**, with official address at San Lazaro Compound, Rizal Avenue, Sta. Cruz, 1003 Manila (hereinafter called "the Entity") of the one part;

-AND-

PHIL PHARMAWEALTH INC. (PPI) as represented by **MS. LALAIN P. ROCERO, Vice President-Government Account**, with official address at Suite 3001, 30th Floor Tektite East Tower, PSE, Exchange Road, Ortigas Center, Pasig City (herein after called the "SUPPLIER") of the other part."

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Procurement of Losartan Tablet under IB No. 2019-039** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Seventy-Eight Million Eighty Six Thousand Four Hundred Philippine Pesos (PhP78,086,400.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement viz.:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Bid Bulletin Nos. 1 & 2;
 - (g) the Performance Security; and
 - (h) the Entity's Notice of Award
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
