Cruz, 1003 Manila (hereinafter called "the DOH") of the one part;

-AND-

**MULTI-FOLD LINKS, INC.** as represented by **ARLYN L. SOLITARIO**, Chief Operating Officer, with official address at Platinum 2000 Bldg. No. 07 Annapolis St. Greenhills, City of San Juan (herein after called the "SERVICE PROVIDER") of the other part.

WHEREAS the DOH invited Bids for certain goods and ancillary services, viz., **Supply, Installation, Configuration and Commissioning of DOH ICT Disaster Recovery Site at Center for Health Development III** under IB No. 2018-301 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Twenty-Three Million Three Hundred Forty Five Thousand Six Hundred Twenty Nine Philippine Pesos and Forty One Centavos (PhP23,345,629.41)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract;
  - (f) the Bid Bulletins;
  - (g) the Performance Security; and
  - (h) the Notice of Award

3. In consideration of the payments to be made by the DOH to the SERVICE PROVIDER as hereinafter mentioned, the SERVICE PROVIDER hereby covenants with the DOH to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

5. In case of disputes, venue of such court action shall be laid exclusively in the proper court in the City of Manila, Philippines.
