SO THE PUBLIC MAY KNOW:

THIS AGREEMENT made the _____ day of **SEP 02 2020** between the **DEPARTMENT OF HEALTH (DOH)** of the Republic of the Philippines, as represented by **DR. ENRIQUE A. TAYAG, Director IV**, with official address at San Lazaro Compound, Rizal Avenue, Sta. Cruz, 1003 Manila (hereinafter called "the Entity") of the one part;

COMMSOURCE SYSTEMS AND INTEGRATED SOLUTIONS, INC. as represented by **MS. PRUD E. DE LEON**, Account Manager, with official address at **62 Ilocos Sur Bago Bantay, Ramon Magsaysay, Quezon City**, (herein after called the "SUPPLIER") of the other part."

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Procurement of Multimedia Production Laptop under IB No. 2020-167** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million One Hundred Sixty-Nine Thousand Six Hundred Seventy-Two Philippine Pesos (PhP1,169,672.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - b) the Schedule of Requirements;
 - c) the Technical Specifications;
 - d) the Bid Bulletin Nos. 1, 2, 3, and 4
 - e) the General Conditions of Contract;
 - f) the Special Conditions of Contract;
 - g) the Entity's Notice of Award; and
 - h) the Performance Security
