PROCUREMENT OF NVBSP COLLATERALS – ITEM NO. 2
under IB No. 2020-218

SO THE PUBLIC MAY KNOW:

THIS AGREEMENT made the _____ day of **DEC 17 2020** between the **DEPARTMENT OF HEALTH (DOH)** of the Republic of the Philippines, as represented by **DR. NESTOR F. SANTIAGO, JR., Assistant Secretary of Health, Public Health Services Team**, with official address at San Lazaro Compound, Rizal Avenue, Sta. Cruz, 1003 Manila (hereinafter called “the Entity”) of the one part;

-AND-

CYN TRADING & SERVICES, INC., as represented by **MS. CRISTINA D. BAUTISTA, Authorized Sales Representative**, with official address at #10 Blake St., Filinvest II, Batasan Hills, Quezon City, herein after called the (“SUPPLIER”) of the other part.”

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., Procurement of NVBSP Collaterals – Item No. 2 – Hand Towel under IB No. 2020-218 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Hundred Sixty-Four Thousand One Hundred Thirty-Five Philippine Pesos (PhP464,135.00)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a) The Supplier’s Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder’s response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity’s bid evaluation;
 - b) the Schedule of Requirements;
 - c) the Technical Specifications;
 - d) the General Conditions of Contract;
 - e) the Special Conditions of Contract;
 - f) the Performance Security;
 - g) the Entity’s Notice of Award; and
 - h) the Bid Bulletin Nos. 1 and 2
3. In consideration of the payments to be made by the Entity to the SUPPLIER as hereinafter mentioned, the SUPPLIER hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
