PROCUREMENT OF COPPER INTRAUTERINE DEVICE (TCU 380-A)
under IB No. 2020-181**

SO THE PUBLIC MAY KNOW:

THIS AGREEMENT made the _____ day of OCT 14 2020 between the **DEPARTMENT OF HEALTH (DOH)** of the Republic of the Philippines, as represented by **DR. NAPOLEON L. AREVALO, Director IV, Disease Prevention and Control Bureau**, with official address at San Lazaro Compound, Rizal Avenue, Sta. Cruz, 1003 Manila (hereinafter called "the Entity") of the one part;

-AND-

RBC-MDC CORPORATION (RBCJ Pharmacy), as represented by **MS. JENELL D. TABLA, Government Business Manager**, with official address at RBC Corporate Center Don Jesus Blvd., Alabang Hills Cupang, Muntinlupa City, (herein after called the "SUPPLIER") of the other part."

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., Procurement of Copper Intrauterine Device (TCU 380-A under IB No. 2020-181 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Million Forty Thousand Philippine Pesos (PhP3,040,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - c) the Technical Specifications;
 - d) the General Conditions of Contract;
 - e) the Special Conditions of Contract;
 - f) the Performance Security;
 - g) the Entity's Notice of Award; and
 - h) the Bid Bulletin Nos. 1, 2, 3, 4 and 5
