under IB No. 2020-227

SO THE PUBLIC MAY KNOW:

THIS AGREEMENT made the _____ day of NOV 18 2020 between the **DEPARTMENT OF HEALTH (DOH)** of the Republic of the Philippines, as represented by **DR. ENRIQUE A. TAYAG, Director IV**, Knowledge Management and Information Technology Service, with official address at San Lazaro Compound, Rizal Avenue, Sta. Cruz, 1003 Manila (hereinafter called "the Entity") of the one part;

-AND-

INTEGRATED COMPUTER SYSTEMS, INC. as represented by **MS. ADELIANA SY-LU**, Vice-President-Field Sales, with official address at **3rd Flr. Limketkai Bldg., Ortigas Avenue, Greenhills, San Juan City**, (herein after called the "SUPPLIER") of the other part."

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Procurement of Server for the Epidemiology Bureau (EB) Emergency Operation Center (EOC) System** under **IB No. 2020-227** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Seven Hundred Five Thousand Philippine Pesos (PhP705,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a) The Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Entity's bid evaluation;
 - b) the Schedule of Requirements;
 - c) the Technical Specifications;
 - d) the Bid Bulletin Nos. 1 and 2;
 - e) the General Conditions of Contract;
 - f) the Special Conditions of Contract;
 - g) the Entity's Notice of Award; and
 - h) the Performance Security

3. In consideration of the payments to be made by the Entity to the SUPPLIER as hereinafter mentioned, the SUPPLIER hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
