PROCUREMENT OF SPRAY CAN AND REPAIR KIT
under IB No. 2020-142

SO THE PUBLIC MAY KNOW:

THIS AGREEMENT made the JUL 24 2020 day of 20 between the
DEPARTMENT OF HEALTH (DOH) of the Republic of the Philippines, as represented by **DR.**
NAPOLEON L. AREVALO, Director IV, Disease Prevention and Control Bureau, with
official address at San Lazaro Compound, Rizal Avenue, Sta. Cruz, 1003 Manila (hereinafter called
“the Entity”) of the one part;

-AND-

PYCOR, INC., as represented by **MS. NORA P. QUINCENA, Market Development Officer**, with official address at M1 Central Bldg., cor. Matingas St., E. Rod. Sr. Ave., Don Manuel Quezon City, (herein after called the “SUPPLIER”) of the other part.”

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., Procurement of Spray Can and Repair Kit under IB No. 2020-142 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Million Seven Hundred Forty Thousand Philippine Pesos (PhP4,740,000.00)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- a) The Supplier’s Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder’s response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity’s bid evaluation;
- b) the Schedule of Requirements;
- c) the Technical Specifications;
- d) the General Conditions of Contract;
- e) the Special Conditions of Contract;
- f) the Performance Security;
- g) the Entity’s Notice of Award; and
- h) the Bid Bulletin No. 1
