THIS AGREEMENT made the _____ day of _____ 20____ between the
DEPARTMENT OF HEALTH of the Republic of the Philippines, as represented by
FRANCISCO T. DUQUE III, MD, MSc, Secretary of Health, with official address at San Lazaro
Compound, Rizal Avenue, Sta. Cruz, 1003 Manila (hereinafter called "the DOH") of the one part;

-AND-

VARIANCE TRADING CORPORATION as represented by MR. HENRY S. DELA
CRUZ, National Sales Manager, with official address at AGG-CT II Bldg. V. Luna Road Cor. Matapat
Street, Brgy. Pinyahan, Quezon City (herein after called the "SUPPLIER") of the other part."

WHEREAS the DOH invited Bids for certain goods and ancillary services, viz.,
Procurement for the Supply, Delivery, Testing and Commissioning of Brand New Digital
Mobile Radiographic X-ray Machine under EP No. 2020-011 and has accepted a Bid by the
Supplier for the supply of those goods and services in the sum of **Eight Hundred Twenty Eight
Million Philippine Pesos (PhP828,000,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement viz.:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the Request for Quotation;
 - (e) the Entity's Notice of Award; and
 - (f) Notice of Award of Contract; and the Bidder's conforme thereto; and
 - (g) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the payments to be made by the DOH to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.


