SO THE PUBLIC MAY KNOW:

THIS AGREEMENT made the MAR 21 2019 day of 20 between the
DEPARTMENT OF HEALTH (DOH) of the Republic of the Philippines, as represented by DR.
MYRNA C. CABOTAJE, Undersecretary of Health, with official address at San Lazaro
Compound, Rizal Avenue, Sta. Cruz, 1003 Manila (hereinafter called "the DOH") of the one part;

-AND-

GREPCOR DIAMONDE, INC. as represented by SHEILA P. PATDU, National Sales
Manager, with official address at 14-A 3rd St., New Manila, Quezon City, (herein after called the
"SUPPLIER") of the other part."

WHEREAS the DOH invited Bids for certain goods and ancillary services, viz.,
Procurement of Blood Bags for Item No. 2 under IB No. 2019-002 and has accepted a Bid by the
Supplier for the supply of those goods and services in the sum of Fourteen Million Forty
Thousand Philippine Pesos (PnP 14,040,000.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively
assigned to them in the Conditions of Contract referred to.

other documents/statements submitted (e.g. bidder's response to clarifications
on the bid), including corrections to the bid resulting from the DOH's bid
evaluation;
 - b) the Schedule of Requirements;
 - c) the Technical Specifications;
 - d) the General Conditions of Contract;
 - e) the Special Conditions of Contract;
 - f) the Performance Security; and
 - g) the DOH's Notice of Award

The DOH hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
