**CONTRACT AGREEMENT No. GOP-C-2019-014**

**PROCUREMENT OF NUCLEIC ACID AMPLIFICATION TESTING REAGENTS  
COMPATIBLE TO EXISTING NAT MACHINE (PROCLEIX PANTHER SYSTEM)  
UNDER DC NO. 2019-006**

**SO THE PUBLIC MAY KNOW:**

THIS AGREEMENT made the MAY 16 2019 day of 20 between the  
**DEPARTMENT OF HEALTH** of the Republic of the Philippines, as represented by **DR.  
MYRNA C. CABOTAJE**, Undersecretary of Health, with official address at San Lazaro  
Compound, Rizal Avenue, Sta. Cruz, Manila 1003 (hereinafter called "the DOH") of the one part;

- and -

**GREPCOR DIAMONDE, INC.**, as represented by **MS. SHEILA P. PATDU**, National Sales  
Manager, with official address at 14-3 3<sup>rd</sup> St., New Manila, Quezon City (hereinafter called "the  
Supplier") of the other part.

WHEREAS, the DOH invited Bids for certain goods and ancillary services for the  
Procurement of Nucleic Acid Amplification Testing Reagents Compatible to Existing NAT  
Machine (Procleix Panther System) under DC No. 2019-006 and has accepted a Bid by the  
Supplier for the supply of those goods and services in the sum of **Forty-Five Million Eighty  
Thousand Philippine Pesos (PhP 45,080,000.00)** (hereinafter called "the Contract Price").

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement, words and expressions shall have the same meanings as are respectively  
assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part  
of this Agreement, to wit:
  - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other  
documents / statements submitted (e.g. bidder's response to clarifications on the bid),  
including corrections to the bid resulting from the DOH's bid evaluation;
  - (b) the Schedule of Requirements
  - (c) the Technical Specifications;
  - (d) the Notice of Award.
3. In consideration of the payments to be made by the DOH to the Supplier as hereinafter  
mentioned, the Supplier hereby covenants with the DOH to provide the goods and services and  
to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The DOH hereby covenants to pay the Supplier in consideration of the provision of the goods  
and services and the remedying of defects therein, the Contract Price or such other sum as may  
become payable under the provisions of the contract at the time and in the manner prescribed  
by the contract.
