NEGOTIATED PROCUREMENT FOR PRODUCTION OF INFOMERCIAL SERIES
FOR BIDA SOLUSYON CAMPAIGN
Under NP No. 2020-040

SO THE PUBLIC MAY KNOW:

THIS AGREEMENT made on the _____ day of NOV 27 2020 between the Department of Health (DOH) of the Republic of the Philippines, as represented by **DR. BEVERLY LORRAINE C. HO, Director IV, Health Promotion and Communication Service**, with official address at San Lazaro Compound, Rizal Avenue, Sta. Cruz, 1003 Manila (hereinafter called "the Entity") of the one part;

-AND-

UXS INC. as represented by **MS. MARIA MADONNA G. TARRAYO, President and Chief Executive Officer**, with official address at 104 Paseo de Roxas St. cor. Perea St., Legaspi Village, Makati City (herein after called the "SERVICE PROVIDER") of the other part.

WHEREAS the Entity invited Bids for certain goods and ancillary services for **Negotiated Procurement for the Production of Infomercial Series for BIDA Solusyon Campaign** under NP No. 2020-040 and has accepted a Bid by the SERVICE PROVIDER for the supply of those goods and services in the sum of **Ten Million Philippine Pesos (PhP10,000,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a) The Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - b) the Schedule of Requirements;
 - c) the Technical Specifications;
 - d) the Price Quotation; and
 - e) the Entity's Notice of Award
3. In consideration of the payments to be made by the Entity to the SERVICE PROVIDER as hereinafter mentioned, the SERVICE PROVIDER hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the SERVICE PROVIDER in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines the date and year before written.
