THIS AGREEMENT made the _____ day of _____ 20____ between the

NESTOR F. SANTIAGO, JR., Assistant Secretary of Health, Public Health Services Team**,
with official address at San Lazaro Compound, Rizal Avenue, Sta. Cruz, 1003 Manila (hereinafter
called "the Entity") of the one part;

TOPBEST PRINTING CORPORATION, as represented by **MS. SHIRLEY L.
DIONISIO, Sales Manager**, with official address at 197 Ma. Clara St., between 9th and 10th
Avenue, Grace Park, Caloocan City, (herein after called the "SUPPLIER") of the other part."

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz.,
Procurement of Blood Bag Label and Donation ID Sticker with Ribbon and Compatible Printer
under IB No. 2020-141 and has accepted a Bid by the Supplier for the supply of those goods and
services in the sum of **Two Million Thirty-Six Thousand Nine Hundred Forty-Four Philippine
Pesos (Php2,036,944.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively

 - c) the Technical Specifications;
 - d) the General Conditions of Contract;
 - e) the Special Conditions of Contract;
 - f) the Performance Security;
 - g) the Entity's Notice of Award; and
 - h) the Bid Bulletin Nos. 1 and 2
