SO THE PUBLIC MAY KNOW:

THIS AGREEMENT made the _____ day of _____ 2021 between the
DEPARTMENT OF HEALTH (DOH) of the Republic of the Philippines, as represented by DR.
NESTOR F. SANTIAGO, JR., Assistant Secretary of Health, Public Health Services Team,
with official address at San Lazaro Compound, Rizal Avenue, Sta. Cruz, 1003 Manila (hereinafter
called “the Entity”) of the one part;

-AND-

AVECILLA TRADING as represented by MS. MA. BETINA ELY C. AVECILLA,
Sole Proprietor, with official address at Blk 25 Lot 19, St. Jude, Bacoor, Cavite, (herein after called
the “SUPPLIER”) of the other part.”

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz.,
Procurement of NVBSP Collaterals – Item No. 5 – Portable Hand Held Fan under IB No. 2020-218
and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of
Four Hundred Sixty-One Thousand Nine Hundred Philippine Pesos (PhP461,900.00)
(hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively
assigned to them in the Conditions of Contract referred to.

- the Technical Specifications;
- the General Conditions of Contract;
- the Special Conditions of Contract;
- the Performance Security;
- the Entity's Notice of Award; and
- the Bid Bulletin Nos. 1 and 2


