RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT FOR THE PROCUREMENT OF VARIOUS OFFICE FURNITURE AND APPLIANCES FOR HEALTH POLICY AND SYSTEMS DEVELOPMENT TEAM SVP NO. 2020-051

WHEREAS, the Central Office Bids and Awards Committee (COBAC)-D received the Purchase Requests (PRs) from the Health Policy and Systems Development Team (HPSDT) for the Procurement of Various Office Furniture and Appliances in accordance with Republic Act (RA) 9184 and its 2016 Revised Implementing Rules and Regulations (IRR) through the General Appropriations Act (GAA) of 2020 with a Total Approved Budget for the Contract (ABC) of Three Hundred Fifteen Thousand Seven Hundred Sixty Six Philippine Pesos (PhP315,766.00), to wit:

WHEREAS, COBAC Resolution No. 2020-343, "Recommending Approval for the Use of Negotiated Procurement through Small Value Modality for the Procurement of Various Office Furniture and Appliances for Health Policy and Systems Development Team", was approved;

WHEREAS, the Technical Working Group (TWG) was created through the issuance of Department Personnel Order (DPO) COBAC No. 2020-323 dated 14 October 2020;

WHEREAS, on 15 October 2020, the Request for Quotation (RFQ) was posted in the PhilGEPS and DOH websites and other conspicuous places within the premises of the DOH;

WHEREAS, on 16 October 2020, the RFQ was sent through electronic mail (e-mail) to three (3) prospective bidders, to wit:

1. Joslor Enterprises (JE);

2. Roseco Marketing Ventures (RMV); and
3. Distinctive Blinds and Office Systems, Inc. (DBOSI)

WHEREAS, pursuant to Annex "H" Section (V)(D)(8)(b)(ii) of the 2016 IRR of RA 9184, the BAC shall prepare and send the RFQ to at least three (3) suppliers, contractors or consultants of known qualifications and receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;

WHEREAS, on 20 October 2020, the Submission and Opening of Quotations took place as scheduled at 9:00 A.M. at the COBAC Conference Room, Department of Health (DOH);

WHEREAS, one (1) prospective bidder, JE, submitted its quotation;

WHEREAS, the envelope containing the eligibility and technical documents was opened and the presence and completeness of each document was verified by the COBAC-D. Upon checking, JE was declared "ELIGIBLE" and "PASSED" and its quotation was read out publicly and posted in the Abstract of Quotation, to wit;
