

**RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT FOR THE
PROCUREMENT OF CONSULTING SERVICES FOR THE HIRING OF AN INDIVIDUAL
CONSULTANT FOR THE DEVELOPMENT OF STANDARD MONITORING AND
EVALUATION FRAMEWORK, POLICIES, PROCEDURES AND PROTOCOLS FOR THE
NATIONAL eHEALTH PROGRAM
REI-CS-GOP-2016-009**

WHEREAS, Competitive Bidding for the Procurement of Consulting Services for the Hiring of an Individual Consultant for the Development of Standard Monitoring and Evaluation Framework, Policies, Procedures and Protocols for the National eHealth Program was conducted in accordance with Republic Act (RA) 9184 and its Revised Implementing Rules and Regulations (IRR) with an Approved Budget of the Contract of Eight Hundred Forty Thousand Philippine Pesos (PhP 840,000.00);

WHEREAS, the COBAC Resolution No. 2016-198 dated 11 May 2016. "Recommending Approval of Shortlisting for the Procurement of Consulting Services for the Hiring of an Individual Consultant for the Development of Standard Monitoring and Evaluation Framework, Policies, Procedures and Protocols for the National eHealth Program" was approved, to wit:

1. Approve the result of the evaluation for the shortlisted consultant, Mr. Peñas; and
2. That Mr. Peñas be declared shortlisted for the project and subsequently be issued the Letter of Invitation to submit the technical and financial proposal.

WHEREAS, the COBAC Resolution No. 2016-198-A dated 01 August 2016 "Recommending Approval on the Result of the Combined Technical and Financial Evaluation for the Procurement of Consulting Services for the Hiring of an Individual Consultant for the Development of Standard Monitoring and Evaluation Framework, Policies, Procedures and Protocols for the National eHealth Program" was approved, to wit:

1. Recommend for the approval of the results of the combined technical and financial evaluation;
2. Declare Mr. Peñas as the Single Highest Rated Responsive Bid (SHRRB);
3. Upon approval, proceed with the post-qualification and Contract Negotiation with Mr. Peñas as the SHRRB.

WHEREAS, on 08 August 2016, upon confirmation of the availability of the end-user representative, the Letter of Invitation to Negotiate and to submit their post qualification requirements was sent to Mr. Peñas to clarify and discuss including but not limited to scope of services, methodology, financial proposal, duration of engagement and terms of payment;

WHEREAS, the Contract Negotiation took place as scheduled on 10 August 2016, 11:30 AM at the COBAC Conference Room, Ground Floor, Bldg. 6, DOH, San Lazaro Compound, Rizal Avenue, Sta. Cruz Manila. The said negotiation was attended by the representatives of KMITS and Mr. Peñas. The latter raised the following issues and concerns regarding the TOR:

WHEREAS, on 15 August 2016, the COBAC-B Secretariat sent the Minutes of the Contract Negotiation to Mr. Peñas through email for their comment and concurrence;

WHEREAS, on 16 August 2016, the Mr. Peñas concurred and signed the Minutes of the Contract Negotiation;

WHEREAS, upon deliberation the COBAC-B decided to award the contract and declared Mr. Peñas as determined to be the Single Rated and Responsive Bidder (SRRB) with the Total Contract Price of **Eight Hundred Four Thousand Philippine Pesos (PhP804,000.00)**;

WHEREAS, at the time of the signing of this resolution there was no pending incident, no pending MR, no pending protest and the COBAC B followed the requirements set forth in RA 9184;

NOW THEREFORE, in consideration of the above premises, the herein members of the COBAC HEREBY RESOLVE to award the contract to the Mr. Joseph Laurence V.
