**RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT FOR THE
PROCUREMENT OF PROFESSIONAL VIDEO CAMERA HD-REBID
IB NO. 2019-195-A**

WHEREAS, Competitive Bidding for the Procurement of Professional Video Camera HD-Rebid was conducted in accordance with Republic Act (RA) 9184 and its 2016 Revised Implementing Rules and Regulations (IRR) through the General Appropriations Act (GAA) of 2019 with a Total Approved Budget for the Contract (ABC) of Three Million Four Hundred Thousand Philippine Pesos (PhP3,400,000.00):

WHEREAS, COBAC Resolution No. 2019-340, "Declaration of Failure of Bidding for the Procurement of Professional Video Camera HD", was approved;

WHEREAS, on 22 August 2019, the Mandatory Review and Pre-Procurement Conference took place as scheduled at 1:00 P.M. at the Central Office Bids and Awards Committee Conference Room, Department of Health (DOH), to discuss the details of the procurement at hand.

WHEREAS, on 28 August 2019, the Invitation to Bid (IB) was posted in the PhilGEPS website and other conspicuous places within the premises of the DOH for a continuous period of seven (7) calendar days;

WHEREAS, the Technical Working Group (TWG) was created through the issuance of Department Personnel Order (DPO) COBAC No. 2019-368 dated 11 September 2019;

WHEREAS, on 04 September 2019, a Pre-Bidding Conference took place as scheduled at 10:00 A.M. at COBAC Conference Room, DOH, with two (2) prospective bidders attending, namely:

1. Circuit Solutions, Inc. (CSI); and
2. Solid Video Corp. (SVC).

WHEREAS, on 05 September 2019, Minutes of Meeting of the Pre-Bidding Conference was posted on DOH website;

WHEREAS, on the same date, the COBAC-B emailed KMITS requesting confirmation for any changes / modification on technical specifications as discussed during the Pre-Bidding Conference;

WHEREAS, on 11 September 2019, a revised PR and a memorandum was received from KMITS responding on the comments, changes and recommendation raised during the Pre-Bidding Conference;

WHEREAS, Bid Bulletin No. 1, dated 17 September 2019, was issued to clarify the issues and concerns raised during the Pre-Bidding Conference and to announce the new schedule of activities;

WHEREAS, on 25 September 2019, the Submission and Opening of Bids took place as re-scheduled at 9:00 AM at the COBAC Conference Room, DOH. Two (2) prospective bidders bought the bidding document and subsequently submitted their respective proposals, namely, SVC and Infocentric Solutions, Inc. (ISI);

WHEREAS, the first envelopes, containing the Eligibility and Technical Documents were individually opened and the presence, completeness and correctness of all the documents were verified by the COBAC-B in the presence of the prospective bidders' representative. Upon checking, SVC and ISI were declared "ELIGIBLE;"

WHEREAS, the second envelopes containing the Financial Proposals were individually opened and the presence, completeness and correctness of the Financial Documents were verified by the COBAC-B. Upon examination, the two (2) "ELIGIBLE" bidders were rated "PASSED" and their respective proposals were read out publicly and posted in the Abstract of Bids, to wit:

WHEREAS, SVC was declared Lowest Calculated Bidder (LCB) subject to further review and correction of the financial proposal, to determine the bona fide Lowest Calculated Bidder;

WHEREAS, the bids for the item listed below were found to be substantially complying:

WHEREAS, on 26 September 2019, the detailed evaluation of the submitted proposal on the Financial aspect of the documents of the LCB for the above-cited lot was undertaken by the designated TWG;

WHEREAS, on the same day, the TWG, upon evaluation found the bid of SVC “complying” with the financial requirement and submitted their evaluation report;

WHEREAS, on 02 October 2019, the cited TWG Report was presented to the COBAC-B during its 37th Meeting and concurred with the recommendation of TWG to declare the bid of SVC as “complying” therefore, instructed to proceed with the post-qualification of the LCB upon receipt of the additional documentary requirements;

WHEREAS, on 02 October 2019, a notification was issued to SVC through electronic mail, requesting for the submission of the additional documentary requirements within non-extendible period of five (5) calendar days (cd) upon receipt of the notification;

WHEREAS, on 07 October 2019, SVC submitted its additional documentary requirement within the prescribed timeline;

WHEREAS, on 09 October 2019, the cited additional documentary requirement was evaluated by TWG and found the bid of SVC “responsive” and submitted its post-qualification report;

WHEREAS, on 16 October 2019, the cited TWG Report was presented to the COBAC-B during its 38th Meeting. Upon review and deliberation, concurred with the TWG recommendation and declared the bid of SVC, “post-qualified;”

- **WHEREAS**, on the same date, the TWG submitted the Bid Evaluation and Post-Qualification Evaluation Reports citing the bid of the LCB, SVC, “responsive” on the submitted documents;

WHEREAS, on the same date, the COBAC-B reviewed and deliberated the TWG report, as well as the documents and response submitted by the LCB and the following are the salient points of discussion:


