WHEREAS, the Central Office Bids and Awards Committee (COBAC) - D received a request from the Health Policy Development and Planning Bureau (HPDPB) for the Subscription to UpToDate for the Department of Health in accordance with the Republic Act (RA) 9184 and its 2016 Revised Implementing Rules and Regulations (IRR) through the General Appropriations Act of 2021 with a Total Approved Budget for the Contract (ABC) of One Million Five Hundred Thousand Philippine Pesos (Php1,500,000.00), to wit:
