#### RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT FOR ITEM NO. 1 FOR THE PRINTING OF UNIVERSAL HEALTH CARE (UHC) BROCHURE & POSTER SVP NO. 2019-079

WHEREAS, the Central Office Bids and Awards Committee (COBAC)-D received the request from the Health Promotion and Communication Service (HPCS) for the Printing of Universal Health Care (UHC) Brochure & Poster in accordance with Republic Act (RA) 9184 and its 2016 Revised Implementing Rules and Regulations (IRR) through the General Appropriations Act of 2019 with a Total Approved Budget for the Contract (ABC) of Five Hundred Fifty Thousand Philippine Pesos (Php550,000.00):

WHEREAS, the COBAC Resolution No. 2019-375, "Recommending Approval for the Use of Negotiated Procurement through Small Value Modality for the Printing of Universal Health Care (UHC) Brochure & Poster", was approved;

WHEREAS, the Technical Working Group (TWG) was created through the issuance of Department Personnel Order (DPO) COBAC No. 2019-339 dated 03 September 2019;

WHEREAS, on 12 September 2019, the Request for Quotation (RFQ) was posted in the PhilGEPS website and in conspicuous places within the premises of the DOH for a continuous period of three (3) calendar days;

WHEREAS, pursuant to Annex "H" Section V (D)(8)(bii), the BAC shall prepare and send the RFQs to at least three (3) suppliers. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;

WHEREAS, the COBAC-D invited the following suppliers to submit their proposals:

1. Color1digital, Inc. (CDI);
2. Kayumanggi Press, Inc. (KPI); and,
3. VJ Graphic Arts, Inc. (VIGAI).

WHEREAS, on 17 September 2019, the Submission of Quotations took place but due to lack of quorum, the Opening was rescheduled on 18 September 2019 at 9:00 A.M. at the COBAC Conference Room, G/F, Building 6, DOH;

WHEREAS, thirteen (13) prospective bidders submitted their respective proposals, namely;

1. Visual Color Inc. (VCI)
2. Gilcor Printing Press (GPP)
3. New Age Graphics Inc. (NAGI);
4. Mexico Printing Company, Inc. (MPCI);
5. Velprint Corporation (VC);
6. Gorilla Trading (GT);
7. Color1digital, Inc. (CDI);

8. VJ Ghraphic Arts, Inc. (VJGAI);
9. Innovation Printshoppe, Inc. (IPI);
10. Dependable Packaging & Printing House Corp. (DPPHC);
11. Sharmila Printing Press (SPP);
12. Zurbano Publishing & Printing Corp. (ZPPC); and,
13. Progressive Printing Palace, Inc. (PPPI).

**WHEREAS,** the COBAC-D opened the proposal, upon examination, nine (9) bidders were declared “ELIGIBLE”, while four (4) bidders were declared “INELIGIBLE” due to the following reasons:

**WHEREAS**, on 19 September 2019, the evaluation on the submitted documents of the Lowest Calculated Quotation (LCQ), VC, was undertaken by the designated TWG;

**WHEREAS**, on the same date, the TWG found VC “Complying” for Item No. 1 and submitted its report;

**WHEREAS**, 01 October 2019, the TWG report was presented to the COBAC-D during its 38<sup>th</sup> Regular Meeting, and upon review and deliberation, concurred with the TWG recommendation and declared VC “compliant” and recommended the award of contract;

**WHEREAS**, the COBAC-D, upon review and deliberation on the TWG Report as well as verification of the documents, found VC compliant with the requirements. The quotation of VC was declared as the Lowest Calculated and Responsive Quotation (LCRQ) based on the following salient points of discussion:

**WHEREAS**, on 10 October 2019, the Contract Management Division (CMD) reviewed the proposal and submitted its findings, to wit:

Technical Specification submitted by VC.	VC failed to submit the Technical Specifications for the UHC Brochure and Poster as prescribed in Bid Bulletin No. 1 dated 13 September 2019 which was also posted in PhilGEPS website on the same date.

**WHEREAS**, on 15 October 2019, the cited review was presented to the COBAC-D during its 40<sup>th</sup> Regular Meeting, upon review, the Committee requested the TWG – Technical Evaluator (TE) to conduct re-evaluation;

**WHEREAS**, on 21 October 2019, TWG – TE found VC ‘Non-complying’ and submitted its response and report:

**WHEREAS**, on the same date, the cited report was presented to the COBAC-D during its 41<sup>st</sup> Regular Meeting, upon review, the Committee decided to issue a notice of ‘Non-Compliance’ to VC and proceed with the preparation of the Award of the 2<sup>nd</sup> LCQ for Item No. 1 once the notice of ‘Non-Compliance’ to VC has been settled;

**WHEREAS**, on the same date, the Legal, Financial and Technical evaluation for the 2<sup>nd</sup> LCQ, GPP, was presented to the COBAC-D, and upon review and deliberation, concurred with the TWG recommendation and declared GPP ‘compliant’ for Item No. 1 and recommended the award of contract;

**WHEREAS**, on 25 October 2019, the COBAC-D issued a notice of ‘Non-Compliance’ to VC through electronic mail (e-mail);

**WHEREAS**, within three (3) calendar days from receipt of notice of ‘Non-Compliance’, no Request for Reconsideration (RfR) was received from VC;

**WHEREAS**, the COBAC-D, upon review and deliberation on the TWG Report as well as verification of the documents, found GPP compliant with the requirements. The quotation of GPP was declared as the Lowest Calculated and Responsive Quotation (LCRQ) based on the following salient points of discussion:
