**RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT FOR THE
PROCUREMENT OF VEHICLE TOOLS AND EQUIPMENT
SVP NO. 2020-036-A**

WHEREAS, the Central Office Bids and Awards Committee (COBAC) - C received the request from the Administrative Service – General Services Division (AS-GSD) for the Procurement of Vehicle Electrical and Mechanical Tools in accordance with Republic Act (RA) 9184 and its 2016 Revised Implementing Rules and Regulations (IRR) through the General Appropriations Act of 2020 with a Total Approved Budget for the Contract (ABC) of Eight Hundred Twenty Eight Thousand Philippine Pesos (PhP825,000.00), wit:

WHEREAS, the COBAC Resolution No. 2019-262 “Recommending Approval for the Use of Negotiated Procurement through Small Value Modality for the Procurement of Vehicle Tools and Equipment”, was approved;

WHEREAS, the COBAC Resolution No. 2019-262-A “Declaration of Failure of Negotiation through Small Value Modality for the Procurement of Vehicle Tools and Equipment”, was approved;

WHEREAS, the Technical Working Group (TWG) was created through the issuance of Department Personnel Order (DPO) COBAC No. 2020-262 dated 22 July 2020;

WHEREAS, on 25 July 2020, the Request for Quotation (RFQ) was posted in the PhilGEPS and DOH websites and in conspicuous places within the premises of the Department of Health (DOH) for a continuous period of three (3) calendar days;

WHEREAS, the RFQ was sent to eight (8) prospective bidders listed below:

- 1) Napoliz General Merchandise (NGM);
- 2) Velgrand Trading and Marketing Inc. (VTMI);
- 3) HDP Equipment Philippines Inc.(HDPEPI);
- 4) Power-Check Incorporated (PCI);
- 5) Avecilla Trading (AT);
- 6) Leon Cullens Trading (LCT);
- 7) Happy Boutique (HB); and
- 8) Menold Marketing Corporation (MMC)

WHEREAS, pursuant to Annex “H” Section (V) (D) (8) (b) (ii), the BAC shall prepare and send RFQs to at least three (3) suppliers. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;

WHEREAS, on 29 July 2020, the Submission and Opening of Quotations took place as scheduled at 9:00 A.M. at the COBAC Conference Room, DOH wherein one (1) prospective bidder submitted its quotation, namely, MMC;

WHEREAS, the envelope containing the eligibility and technical documents was opened and the presence and validity of all the required documents were verified by the COBAC-C in the presence of the prospective bidder's representative. Upon checking, MMC was declared "ELIGIBLE and PASSED" and its quotation was then read out publicly and posted in the Abstract of Quotations, to wit:

WHEREAS, on 05 August 2020, the TWG reports were presented to the COBAC-C during its 29th Regular Meeting. Upon review and deliberation, the Committee concurred with the TWG recommendation and recommended the award of contract to MMC;

WHEREAS, at the time of signing of this Resolution, there is no pending incident, no pending Request for Reconsideration, no pending protest and the COBAC-C followed the requirements set forth in RA 9184;

NOW THEREFORE, on the basis of the above, the herein members of the COBAC-C
HEREBY RESOLVE to recommend the award of contract to **Menold Marketing Corporation**
determined as the Single Calculated and Responsive Quotation with a Total Contract Price of
Eight Hundred Twenty Thousand Philippine Pesos (PhP820,000.00) inclusive of local taxes for
