**RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT FOR THE PROCUREMENT OF
SIGNAGE-DOH LOGO /
SVP NO. 2020-065 /**

WHEREAS, the Central Office Bids and Awards Committee (COBAC) - C received the request from the Health Promotion and Communication Service (HPCS) for the Procurement of Signage-DOH Logo in accordance with Republic Act (RA) 9184 and its 2016 Revised Implementing Rules and Regulations (IRR) through the General Appropriations Act of 2020 with a Total Approved Budget for the Contract (ABC) of Nine Hundred Ninety Thousand Philippine Pesos (PhP990,000.00):

WHEREAS, the COBAC Resolution No. 2020-392 "Recommending Approval for the Use of Negotiated Procurement through Small Value Modality for the Procurement of Signage-DOH Logo", was approved;

WHEREAS, the Technical Working Group (TWG) was created through the issuance of Department Personnel Order (DPO) COBAC No. 2020-334 dated 17 November 2020;

WHEREAS, on 20 November 2020, the Request for Quotation (RFQ) was posted in the PhilGEPS and DOH websites and in conspicuous places within the premises of the Department of Health (DOH) for a continuous period of three (3) calendar days;

WHEREAS, the RFQ was sent to three (3) prospective bidders listed below:

- 1) A.J.A.E Signage Printing Services (AJAESPS); /
- 2) Ch'i Asia, Inc. (CAI); and
- 3) Pixign Advertising Corporation (PAC).

WHEREAS, pursuant to Annex "H" Section (V) (D) (8) (b) (ii), the BAC shall prepare and send RFQs to at least three (3) suppliers. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;

WHEREAS, on 26 November 2020, the Submission and Opening of Quotations took place as scheduled at 9:00 A.M. at the COBAC Conference Room, DOH wherein one (1) prospective bidder submitted its proposal but did not attend the cited activity, namely, AJAESPS;

WHEREAS, the envelope containing the eligibility and technical documents was opened and the presence and validity of all the required documents were verified by the COBAC-C. Upon checking, AJAESPS was declared "ELIGIBLE and PASSED" and its quotation was then read out publicly and posted in the Abstract of Quotation, to wit:

WHEREAS, the bid for the item listed below was found to be substantially complying:

WHEREAS, on the same date, the evaluation of bid of AJAESPS was undertaken by the designated TWG;

WHEREAS, on 26 November 2020, TWG – Financial, Legal and Technical Evaluators found AJAESPS “Complying” and submitted their respective reports;

WHEREAS, on 03 December 2020, TWG reports were presented to the COBAC-C during its 7th Regular Meeting. Upon review and deliberation, the Committee concurred with the TWG recommendation and recommended the award of contract to AJAESPS;

WHEREAS, at the time of signing of this Resolution, there is no pending incident, no pending Request for Reconsideration, no pending protest and the COBAC-C followed the requirements set forth in RA 9184;

NOW THEREFORE, on the basis of the above, the herein members of the COBAC-C **HEREBY RESOLVE** to recommend the award of contract to **A.J.A.E Signage Printing Services**, determined as the Single Calculated and Responsive Quotation with a Total Contract Price of Eight Hundred Nine Thousand Six Hundred Philippine Pesos (PhP809,600.00) inclusive of local taxes for the procurement of the item listed below:
