**DECLARATION OF FAILURE OF NEGOTIATED PROCUREMENT THROUGH SMALL
VALUE MODALITY FOR THE
PROCUREMENT OF AUDIO DEVICES
SVP NO. 2020-060-A**

WHEREAS, the Central Office Bids and Awards Committee (COBAC)-B received the requests from the Knowledge Management Information and Technology Service (KMITS) for the Procurement of Audio Devices in accordance with the Republic Act (RA) 9184 and its 2016 Revised Implementing Rules and Regulations (IRR) through the General Appropriations Act (GAA) of 2020 for the items listed below with a Total Approved Budget for the Contract (ABC) of Six Hundred Sixty Thousand Philippine Pesos (PhP660,000.00):

WHEREAS, COBAC Resolution No. 2020-375 “Recommending Approval for the Use of an Alternative Method through Negotiated Procurement (Small Value Modality) for the Procurement of Audio Devices under SVP No. 2020-060”, was approved;

WHEREAS, COBAC Resolution No. 2020-375-A “Declaration of Failure of Negotiated Procurement through Small Value Modality for the Procurement of Audio Devices under SVP No. 2020-060”, was approved;

WHEREAS, on 08 December 2020, the Request for Quotation (RFQ) under SVP No. 2020-060-A was posted in the DOH and PhilGEPS websites and in conspicuous places within the premises of the DOH for a continuous period of three (3) calendar days;

WHEREAS, the COBAC-B issued the RFQ through electronic mail to the following prospective bidders:

1. DCI Int'l. I.T Solutions & Services Corp. (DIITSSC);
2. Advance Solutions, Inc. (ASI);
3. American Technologies, Inc. (ATI);
4. Integrated Computer Systems, Inc. (ICSI);
5. Maximum Solutions, Corporation (MSC);
6. S1 Technologies, Inc. (STI);
7. Masangkay Computer Center (MCC);

WHEREAS, pursuant to Annex “H” Section D.8 (b) (ii), the BAC shall prepare and send RFQs to at least three (3) suppliers. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;

WHEREAS, on 11 December 2020, the Submission and Opening of Quotations took place as scheduled at 9:00 A.M. at the COBAC Conference Room, DOH. Only one (1) prospective bidder

WHEREAS, the envelope containing the eligibility and technical documents was opened and the presence, completeness and correctness of the required documents were checked and verified. Upon checking, the lone bidder was declared "INELIGIBLE" and rated "FAILED" due to non-submission of the Omnibus Sworn Statement;

WHEREAS, on the same date, the COBAC-B, upon deliberation, decided to declare a failure of negotiation as provided for in Section 35.1 (b) of the 2016 IRR of RA 9184, the BAC shall declare the bidding a failure when all prospective bidders are declared ineligible;

NOW THEREFORE, in consideration of the above premises, the herein members of the COBAC-B **HEREBY RESOLVE** the following:

1. Declare failure of negotiation for the items listed below with a Total Approved Budget for the Contract (ABC) of Six Hundred Sixty Thousand Philippine Pesos (PhP660,000.00):

Mandate the End-user, KMITS, to conduct a mandatory review and evaluation of the terms, conditions, specifications, including its cost estimates in the RFQ subject to the required approval as provided in Annex "H" Section K of the 2016 Revised IRR of RA 9184 and procure the said items in CY 2021 if still needed, subject to the availability appropriate funds for the purpose.
