COBAC RESOLUTION NO. 2020 -367-A

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT FOR THE PURCHASE AND PRINTING OF NVBSP UMBRELLA SVP NO. 2020-059

WHEREAS, the Central Office Bids and Awards Committee (COBAC)-C received the request from the National Voluntary Blood Services Program (NVBSP) for the Purchase and Printing of NVBSP Umbrella in accordance with Republic Act (RA) 9184 and its 2016 Revised Implementing Rules and Regulations (IRR) through the General Appropriations Act of 2020 with a Total Approved Budget for the Contract (ABC) of Four Hundred Twenty Thousand Philippine Pesos (PhP420,000.00):

WHEREAS, COBAC Resolution No. 2020-367 "Recommending Approval for the Use of Negotiated Procurement through Small Value Modality for the Purchase and Printing of NVBSP Umbrella", was approved;

WHEREAS, on 23 October 2020, the Request for Quotation (RFQ) was posted in the PhilGEPS and DOH websites and in conspicuous places within the premises of the DOH for a continuous period of three (3) calendar days;

WHEREAS, the RFQ was issued to six (6) prospective bidders through electronic mail (e-mail) namely:

1. Gee-line Trading (GLT);
2. St. Christ International Trading (SCIT);
3. CYN Trading and Services Inc. (CYNTSI);
4. Knit and Tuck Merchandising (KTM);
5. Avecilla Trading (AT); and,
6. Happy Boutique (HB).

WHEREAS, pursuant to Annex "H" Section (V) (D) (8) (b) (ii), the BAC shall prepare and send RFQs to at least three (3) suppliers. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;

WHEREAS, the Technical Working Group (TWG) was created through the issuance of Department Personnel Order (DPO) COBAC No. 2020-328 dated 26 October 2020;

WHEREAS, on 28 October 2020, the Submission and Opening of Quotations took place as scheduled at 9:00 A.M. at the COBAC Conference Room, G/F, Building 6, DOH;

WHEREAS, three (3) prospective bidders submitted their respective proposals, namely:

1. GLT;
2. Mitsui Trading Phils. Ltd. Co. (MTPLC); and,
3. King of Kings Trading (KKT).

WHEREAS, the COBAC-C individually opened the proposals of the three (3) prospective bidders. Upon examination, the Committee declared KKT “Ineligible” due to the ground that the submitted Technical Specification and Schedule of Requirements Forms were not duly signed and non-submission of Latest Annual Income Tax Return and Omnibus Sworn Statement;

WHEREAS, the COBAC-C declared GLT and MTPLC “ELIGIBLE” and “PASSED” and their bids were read out publicly and posted in the Abstract of Bids, to wit:

WHEREAS, the COBAC-C declared MTPLC as the lowest bidder as read subject to further arithmetical review and correction of the financial bid to determine the bonifide Lowest Calculated Quotation (LCQ);

WHEREAS, on 29 October 2020, the evaluation on the submitted documents of the MTPLC and GLT were undertaken by the designated TWG;

WHEREAS, the TWG-Financial Evaluator submitted the Abstract of Bid as Calculated, to wit:

WHEREAS, on 03 November 2020, the TWG found MTPLC “complying” and submitted their reports;

WHEREAS, on 04 November 2020, the TWG reports were presented to the COBAC-C during its 3rd Regular Meeting. Upon review and deliberation, the Committee concurred with the TWG recommendation, declaring MTPLC “compliant” and recommended the award of contract;

NOW THEREFORE, in consideration of the above premises, the herein members of the COBAC-C **HEREBY RESOLVES** to recommend the award of contract to **Mitsui Trading Phils. Ltd. Co.** determined as the Lowest Calculated and Responsive Quotation with a Total Contract Price of **Two Hundred Eleven Thousand Six Hundred Eighty Philippine Pesos (PhP211,680.00)** inclusive of taxes for the item listed below:


