WHEREAS, the Central Office Bids and Awards Committee (COBAC)-B received the request from the Knowledge Management Information and Technology Service (KMITS) and Health Facilities and Development Bureau (HFDB) for the Procurement of Various Cameras in accordance with the Republic Act (RA) 9184 and its 2016 Revised Implementing Rules and Regulations (IRR) through the General Appropriations Act (GAA) of 2020 for the items listed below with a Total Approved Budget for the Contract (ABC) of Eight Hundred Fifty Four Thousand Two Hundred Philippine Pesos (PhP854,200.00):

WHEREAS, COBAC Resolution No. 2020-347 “Recommending Approval for the Use of an Alternative Method through Negotiated Procurement (Small Value Modality) for the Procurement of Various Camera under SVP No. 2020-053”, was approved;

WHEREAS, on 09 and 10 November 2020, the Request for Quotation (RFQ) under SVP No. 2020-053 was posted in the DOH and PhilGEPS websites and in conspicuous places within the premises of the DOH for a continuous period of three (3) calendar days;

WHEREAS, the COBAC-B issued the RFQ through electronic mail to the following prospective bidders:

WHEREAS, Bid Bulletin No. 1, dated 12 November 2020, was issued to announce the new schedule of activities and to amend or modify the posted RFQ;

WHEREAS, on 18 November 2020, the Submission and Opening of Quotations took place as scheduled at 9:00 A.M. at the COBAC Conference Room, DOH. However, no quotation was received;

WHEREAS, on the same date, the COBAC-B, upon deliberation, decided to declare a failure of negotiation as provided for in Section 35.1 (a) of the 2016 IRR of RA 9184, the BAC shall declare the bidding a failure when no bids are received;

NOW THEREFORE, in consideration of the above premises, the herein members of the COBAC-B **HEREBY RESOLVE** the following:

1. Declare failure of negotiation for the items listed below through Small Value Modality for Procurement of Various Camera under SVP No. 2020-053 with a Total Approved Budget for the Contract (ABC) of Eight Hundred Fifty Four Thousand Two Hundred Philippine Pesos (PhP854,200.00):
