



Newly Diagnosed HIV Cases in the Philippines

In February 2014, there were 486 new HIV Ab sero-positive individuals confirmed by the STD/AIDS Cooperative Central Laboratory (SACCL) and reported to the HIV and AIDS Registry (Table 1). This is 43% higher compared to the same period last year (n=339 in 2013) [Figure 1].

Most of the cases (96%) were male. The median age was 27 years (age range: 18-63 years). The 20-29 year (62%) age group had the most number of cases.

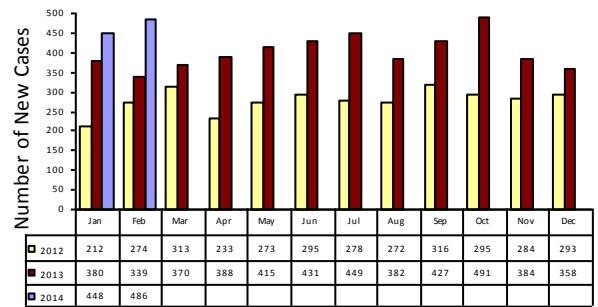


Figure 2. Comparison of the Proportion of Types of Sexual Transmission in 2014, 2013 & Cumulative Data (1984-2014)

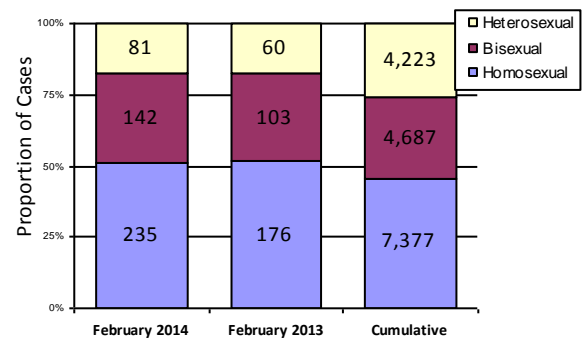
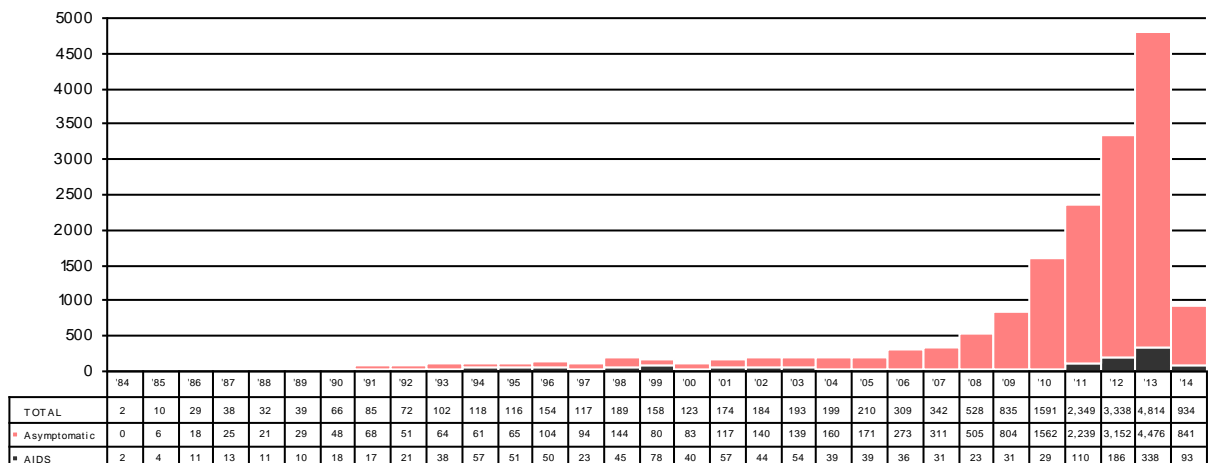


Figure 3. Number of HIV/AIDS Cases Reported in the Philippines by Year, January 1984 to February 2014 (N=17,450)

Reported modes of transmission were sexual contact (458) and needle sharing among injecting drug users (28) [Table 3, page 2]. Males having sex with other males (82%) was the predominant type of sexual transmission [Figure 2]. Most (93%) of the cases were still asymptomatic at the time of reporting [Figure 3].

In February 2014, 83% of the new HIV cases came from NCR, Region 4A, Region 3, Region 7 and Region 11 [Table 2].

Figure 1. Number of New HIV Cases per Month (2012-2014)

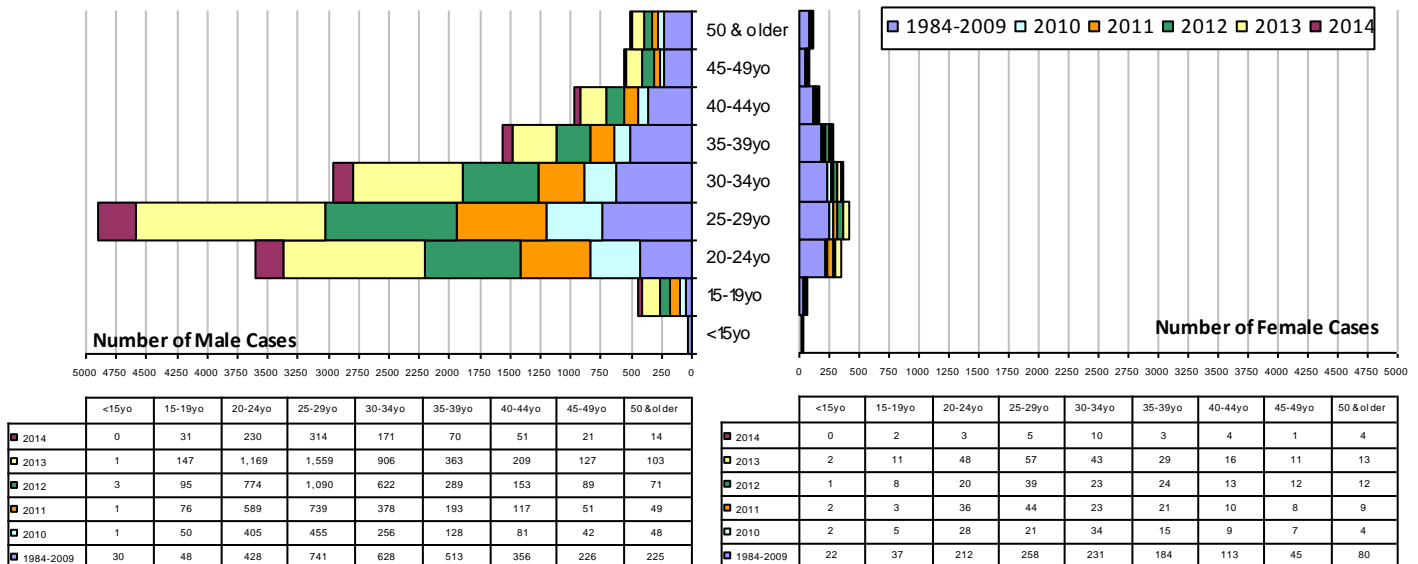


Demographic Characteristics (1984-2014)

Ninety-seven percent of the 934 cases in 2014 were male (902). Ages ranged from 17 to 73 years old (median 28 years). The 20-29 year age group had the most (59%) number of cases for 2014. For the male age group, the most number of cases were found among the 20-24 years old (26%), 25-29 years old (35%), and 30-34 years old (19%) [Figure 4].

From 1984 to 2014, there were 17,450 HIV Ab sero-positive cases reported (Table 1), of which 15,851 (91%) were asymptomatic and 1,599 (9%) were AIDS cases. As shown in Figure 4, there is a significant difference in the number of male and female cases reported. Eighty-nine percent (15,562) were male. Ages ranged from 1-81 years (median 28 years). The age groups with the most number of cases were: 20-24 years (23%), 25-29 (31%), and 30-34 years (19%) [Figure 4].

Modes of Transmission (1984-2014)

In 2014, ninety-seven percent (902) were infected through sexual contact and 3% (32) through needle sharing among injecting drug users (Table 3). There were 872 males and 30 females infected through sexual transmission. The age range of those infected through sexual transmission was 17-73 years old (median 28 years).

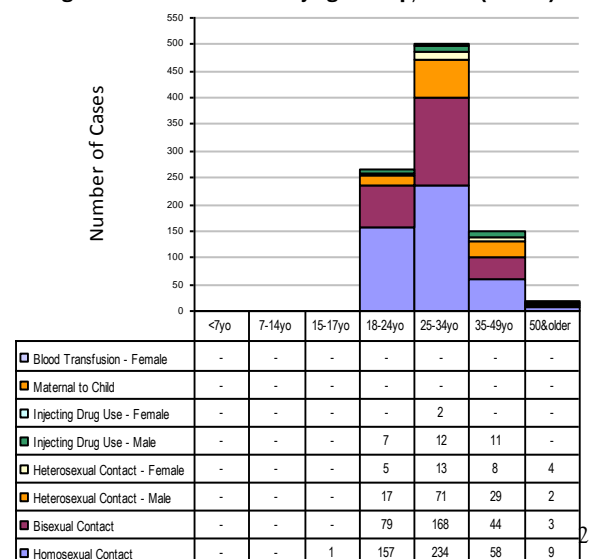
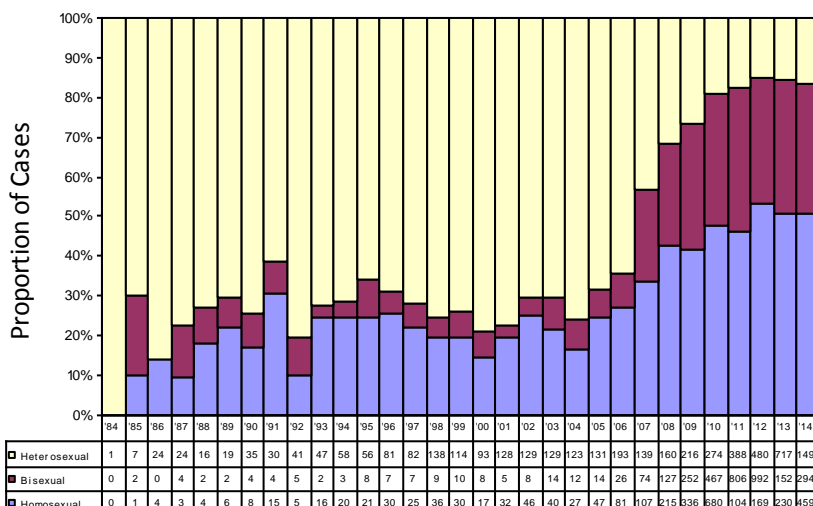
Of the 17,450 HIV positive cases reported from 1984 to 2014, 93% (16,247) were infected through sexual contact, 4% (743) through needle sharing among injecting drug users, <1% (62) through mother-to-child transmission, <1% (20) through blood transfusion and needle prick injury <1% (3) [Table 3]. No data is available for 2% (375) of the cases.

Figure 5. Proportion of Types of Sexual Transmission, January 1984–February 2014

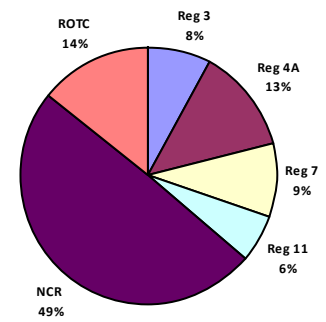


Geographic Distribution (1984-2014)

Since 1984 to present, there were 17,450 cases reported. Almost half (8,046) came from the National Capital Region. [Figure 7]. Thirteen percent (2,132) came from region 4A, followed by 9% (1,463) from Region 7, 8% (1,358) from Region 3, 6% (995) from Region 11 and the rest of the country comprises 14% (2,319) of all the cases.

AIDS Cases (1984-2014)

Of the 934 HIV positive cases in 2014, ninety-three were reported as AIDS cases. All were male. Ages ranged from 19-63 years (median 29 years). Ninety-two acquired the infection through sexual contact (49 homosexual, 35 bisexual and 8 heterosexual) and 1 acquired through injecting drug use.

From 1984 to 2014, there were 1,599 AIDS cases reported. Eighty-two percent (1,314) were male and 18% (285) were female. Median age is 33 years (age range: 1-81 years). Sexual contact was the most common mode of HIV transmission, accounting for 95% (1,524) of all reported AIDS cases. Forty-three percent (649) of sexual transmission was through homosexual contact, followed by heterosexual contact (584) then bisexual contact (291).

Overseas Filipino Workers (1984-2014)

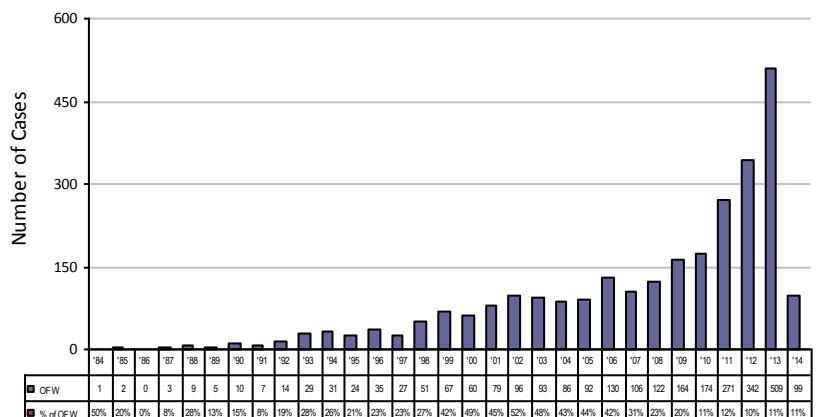
In 2014, there were 99 HIV positive OFWs, comprising 11% of cases reported for the year [Figure 8]. Of these, 87 (88%) were male and 12 (12%) were female. All acquired the infection through sexual contact (43 heterosexual, 33 homosexual and 23 bisexual).

There were 2,737 HIV positive OFWs since 1984, comprising 16% of all reported cases [Figure 8]. Eighty-one percent (2,209) were males. Ages ranged from 18 to 78 years (median 34 years). Sexual contact (98%) was the predominant mode of transmission (Table 4). Eighty-eight percent (2,401) were asymptomatic while 12% (336) were AIDS cases.

Deaths among People with HIV

From January 1984 to February 2014, there were 950 reported deaths among people with HIV [Table 5]. Eighty percent (761) were male. In total, there has been 109 deaths among youth (15-24 years old) and 15 deaths among children (<15 years old).

The annual number of deaths from 1984-2010 ranges from 2 to 36 cases with an average of 14 deaths per year. Beginning 2011, there has been an increase in the number of recorded deaths. There were 69 in 2011, and 177 in 2012. The DOH-NEC established an official reporting form in 2012.

From January to February 2014, there were a total of 16 deaths. All were male [Table 5]. The highest number of deaths occurred in the 25-29 (62%) age group [Figure 9]. This was followed by the 20-24 (12%) and the 30-34 (12%) age groups. For the month of February 2014, there were 8 deaths* [Table 5].

Among the reported deaths in 2014, sexual contact (94%) was the most common mode of HIV transmission (6 homosexual, 6 bisexual, 3 heterosexual). There was 1 case who got infected through injecting drug use. [Figure 9].

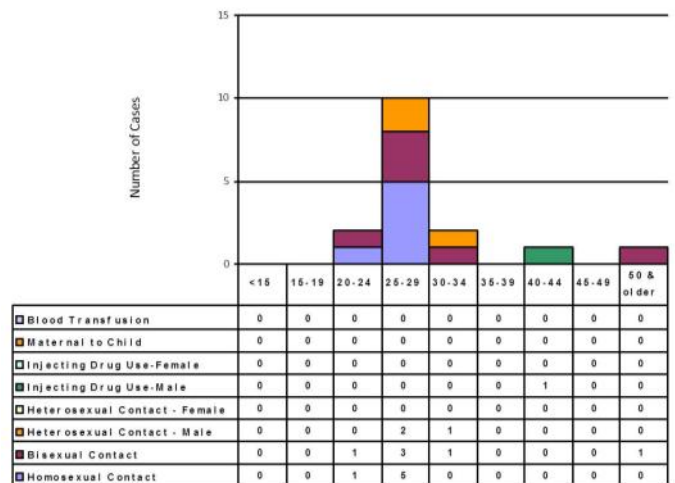

As of February 2014, there are 5,965* People Living with HIV presently on Anti Retroviral Therapy. These are the combined numbers of adult and pediatric patients currently enrolled and accessing Anti-Retroviral drugs in the 18 treatment hubs listed on the right.

Blood Units Confirmed for HIV

In February 2014, 69 blood units were confirmed positive for HIV by RITM. There is no available data yet on the total number of blood units donated.

These are confirmed positive blood units, not blood donors. One donor can donate more than one blood unit. HIV positive blood donors may not be in the HIV & AIDS Registry unless they underwent voluntary counseling and testing as individuals.

Philippine HIV & AIDS Registry

The Philippine HIV & AIDS Registry is the official record of the total number of laboratory-confirmed HIV positive individuals, AIDS cases and deaths, and HIV positive blood units in the Philippines. All individuals in the registry are confirmed by the STD/AIDS Cooperative Central Laboratory (SACCL) at San Lazaro Hospital. While all blood units are confirmed by the Research Institute for Tropical Medicine (RITM). Both are National Reference Laboratories (NRL) of the Department of Health (DOH).

Mandatory HIV testing is unlawful in the Philippines (RA 8504). The process of reporting to the Registry is as follows: All blood samples from accredited HIV testing facilities that are screened HIV reactive are sent to SACCL (individuals) or RITM (blood units) for confirmation. Confirmed HIV positive individuals and blood units are reported to the DOH-National Epidemiology Center (NEC), and are recorded in the Registry.

The Registry is a passive surveillance system. Except for HIV confirmation by the NRL, all other data submitted to the Registry are secondary and cannot be verified. An example would be an individual's reported place of residence. The Registry is unable to determine if this reported address is where the person got infected, or where the person lived after being infected, or where the person is presently living, or whether the address is valid. This limitation has major implications to data interpretation. Thus, readers are cautioned to carefully weigh the data and consider other sources of information prior to arriving at conclusions.
