Reiteration of Functions of Infection Control Committees in Health Facilities and Modification of Staffing Patterns and Further Clarification of the Shortening of Quarantine for the Healthcare Workers

This is to reiterate Department Circular No. 2020-0181 "Reiteration of Functions of Infection Control Committee and Infection Control Team in Health Facilities", wherein all health facilities are instructed to activate their Infection Control Committee (ICC) and Infection Control Team, who are responsible for implementation of their COVID-19 Infection and Prevention Control (IPC) protocols and policies:

- 1. Institutionalize a mechanism for reporting breaks in IPC protocols within the facility;
- 2. Regularly monitor and evaluate the implementation of IPC protocols in their respective health facilities; and
- 3. Provide the necessary training, orientation and refreshers on IPC protocols to all staff.

In addition to above functions, hospital infection control committees are authorized to implement shortened quarantine protocols for their fully vaccinated healthcare workers consistent with health care capacity needs and individualized risk assessment.

Dissemination to all concerned stakeholders is requested.
