Implementation of Malaria Monthly Summary Report Forms at

Barangay and Municipal Level in Palawan

With the view to complement the 1-3-5 malaria surveillance strategy, the National Malaria Control and Elimination Program (NMCEP) has introduced a new set of Malaria forms and registries in 2018. These include the Laboratory Registry, Patient Registry, LLIN Distribution Registry, IRS Registry, Case Investigation Form and Foci Investigation Form. In the Department Memorandum 2019-0358 entitled "Utilization of the NMCEP Registries and Forms", the use of these recording tools in all malaria service delivery points nationwide as has been emphasized as these will become the official source of data for the program's reportorial needs through the Online Malaria Information System (OLMIS).

Though the implementation of these new set of tools is on-going, challenges have been raised by Palawan which remains to be the epicenter of malaria cases in the country. This area performs much of the diagnostic, treatment and vector control activities; thus, recording and reporting also the bulk of intervention data. This leads to delays in the reporting as it takes time to enter all the data in OLMIS. Given this limitation, the program implementers at the frontline suggested the use of monthly summary report forms. This is to facilitate timely data consolidation and reporting prior to completion of data entry in OLMIS.

Relative thereto, the Regional Malaria Control and Elimination Program coordinators are directed to facilitate and monitor the implementation of these Malaria monthly summary report forms in Palawan with further guidance as stated below:

- 1. Two sets of Malaria Monthly Summary Report Form shall be used one at the barangay and another at Rural Health Unit (RHU) level.
 - a. Barangay Level Summary Forms Records summary data for Laboratory Registry and Patient Registry per Data Reporting Unit (DRU) within the catchment barangay.
 - i. Malaria Laboratory Registry Monthly Summary Report Form
 - ii. Malaria Patient Registry Monthly Summary Report Form
 - b. RHU Level Summary Forms Records summary data per barangay for Laboratory Registry, Patient Registry, LLIN Registry and IRS Registry.
 - i. Malaria Laboratory Registry Monthly Summary Report Form
 - ii. Malaria Patient Registry Monthly Summary Report Form
 - iii. LLIN Distribution Registry Monthly Summary Report Form
 - iv. IRS Activity Registry Monthly Summary Report Form

- 2. The Malaria Monthly Summary Report Forms shall be used during monthly data validation meetings and in other activities as deemed applicable.
- 3. The accomplished Malaria Monthly Summary Report Forms shall be compiled by the RHUs. Duplicate copies shall be provided to, verified and validated by the Provincial Health Office.
- 4. Data encoding of the accomplished and validated Malaria Monthly Summary Report Forms shall be done in OLMIS as soon as its counterpart module in the system is made available.
- 5. The use of the Malaria Monthly Summary Report Forms shall not replace the OLMIS encoding of patient-based data for Laboratory Registry and Patient Registry; as well as household based OLMIS data entry for LLIN Distribution Registry and IRS Registry.
- 6. As these are new interventions aimed to support program recording and reporting, the adaptability and usability of the summary forms shall be periodically evaluated by the RHU and PHO implementers together with NMCEP.

Attached are the above-mentioned monthly summary report forms.
