The Department of Health is issuing this Call for Proposals for the 2025 Advancing Health through Evidence Assisted-Decisions with Health Policy and Systems Research (AHEAD with HPSR) program priorities in support of Universal Health Care in the Philippines and in the alignment of the Department's health plans, policies, investments, and monitoring mechanisms with the National Objectives for Health (NOH) as well as the 8 Point Action Agenda of the DOH.

We encourage proponents to account for the overall policy direction of the Department in the design of their research proposals. Specifically, we still encourage to consider the 2023-2028 Medium Term Research Agenda (MTRA 2023-2028) and the Department's 8 Point Action Agenda (AO No. 2023-0015: Adoption of the 8-Point Action Agenda as the Medium Term Strategy of the Health Sector for 2023-2028). Further, as the topics identified are generally broad, we encourage potential researchers to initiate discussions with end-users within the Department to ensure alignment of needs and priorities.
