RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT FOR THE PROCUREMENT OF INTERNET SERVICE PROVIDER FOR THE PHILIPPINE CANCER CENTER NP NO. 2023-041-A

WHEREAS, the procurement of the project listed below was requested in accordance with 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 through the Continuing Appropriation (CONAP) of 2022 with a Total Approved Budget for the Contract (ABC) of Three Million Five Hundred Thousand Philippine Pesos (PhP3,500,000.00), to wit

WHEREAS, COBAC Resolution No. 2023-311, "Declaration of Failure of Bidding for the Procurement of Internet Service Provider for the Philippine Cancer Center under IB No. 2023-229", was approved;

WHEREAS, COBAC Resolution No. 2023-311-A, "Declaration of Failure of Bidding for the Procurement of Internet Service Provider for the Philippine Cancer Center - Rebid under IB No. 2023-229-A", was approved;

WHEREAS, COBAC Resolution No. 2023-311-B, "Recommending Approval for the Use of Negotiated Procurement – Two Failed Biddings for the Procurement of Internet Service Provider for the Philippine Cancer Center under NP No. 2023-041", was approved;

WHEREAS, COBAC Resolution No. 2023-221-C, "Declaration of Failure of Negotiation through Negotiated Procurement - Two-Failed Biddings for the Procurement of Internet Service Provider for the Philippine Cancer Center under NP No. 2023-041", was approved;

WHEREAS, on 15 November 2023, the Mandatory Review and Pre-Procurement Conference was conducted at 09:00 A.M., at the COBAC Conference Room, and through video conferencing via Cisco Webex, to discuss the details of the procurement at hand;

WHEREAS, on 28 November 2023, the COBAC-B requested the Head of Procuring Entity (HoPE) through its Undersecretary of Health of the Field Implementation and Coordination Team (FICT) – NCR and South Luzon for the extension of the re-negotiation in accordance with Section 35 of the 2016 Revised IRR of RA No. 9184, and was subsequently approved;

WHEREAS, on 02 December 2023, the Request for Best and Final Offer (RBFO) was posted in the PhilGEPS and DOH websites, in DOH official social media page, and in conspicuous places within the premises of DOH, for a continuous period of three (3) calendar days;

WHEREAS, on 04 December 2023, the RBFO was issued through electronic mail (e-mail) to the three (3) Prospective Bidders (PBs), namely:

- 1. Converge Information and Communications Technology (CICT);
- 2. Philippine Global Communications, Inc. (PGCI); and,
- 3. Philippine Telegraph and Telephone Corporation (PTTC);

WHEREAS, the Technical Working Group (TWG) was created through the issuance of Department Personnel Order (DPO) COBAC No. 2023-347 dated 04 December 2023;

WHEREAS, on 07 December 2023, the Submission and Opening of Bids took place as scheduled at 9:00 A.M. at the COBAC Conference Room, and through video conferencing via Cisco WebEx. One (1) prospective bidder submitted its bid proposals namely, Eastern Telecommunications Philippines, Inc. (ETPI);

WHEREAS, the envelope containing the Eligibility and Technical Documents was opened and the presence, completeness and correctness of all the documents was individually verified by the COBAC-B in the presence of the prospective bidder's representative. Upon examination, ETPI was declared "Eligible" and subsequently the proposal was read out publicly and posted in the Abstract of Bids, to wit:

WHEREAS, ETPI was declared as the Single Bid as read, subject to further arithmetical review and correction of the financial bid, if necessary and post-qualification;

WHEREAS, on 07 December 2023, the evaluation of the financial proposal of ETPI was undertaken by the designated TWG-Financial Evaluator;

WHEREAS, on the same date, the TWG-Financial submitted its report and the Abstract of Bids as Calculated, to wit:

WHEREAS, on 11 December 2023, the TWG Financial Report and Abstract of Quotation as Calculated were presented to the COBAC-B thru viber. Upon review and deliberation, the Committee decided to proceed with the Post-Qualification evaluation of the SCB, namely, ETPI;

WHEREAS, on the same date, the COBAC-B issued a letter to ETPI through an e-mail requesting for the submission of the Post-Qualification requirements within a non-extendable period of five (5) calendar days upon receipt of the notification;

WHEREAS, on 15 December 2023, ETPI submitted the Post-Qualification documents within the prescribed timeline, and was subsequently endorsed to the TWG for evaluation;

WHEREAS, on 18 December 2023, the TWG-Technical submitted their respective reports and found the bid of ETPI "Responsive" with the requirements;

WHEREAS, on 19 December 2023, the TWG Legal upon evaluation requested to clarify the finding listed below:

WHEREAS, on 22 December 2023, ETPI submitted its response and was subsequently endorsed to the TWG Legal and Financial, for further evaluation;

WHEREAS, on the same date, the TWG Legal and Financial submitted their respective reports and found the bid of ETPI as "Responsive" with the requirements;

WHEREAS, on the same date, the TWG reports were presented to the COBAC-B thru viber. Upon deliberation, the Committee concurred with the recommendation of the TWG and declared ETPI "Post-Qualified", to wit:
