WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Negotiated Procurement as a Result of Two-Failed Bidding for the Procurement of Internet Service Provider for the Philippine Cancer Center under NP No. 2023-041-A and has accepted a Bid by the Service Provider for the supply of those goods and services in the sum of **Three Million Four Hundred Fifty Thousand Philippine Pesos (PhP3,450,000.00)** inclusive of applicable taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- i. Request for Best and Final Offer;
 - i. Schedule of Requirements;
 - ii. Price Quotation Form;
 - iii. Terms of Reference;
 - iv. Technical and Financial Documents; and
 - v. Technical Specifications;
- ii. Winning bidder's bid, including the Technical Requirements and Price Quotations, and all other documents or statements submitted;
- iii. Certificate of Availability of Funds;
- iv. Performance Security;
- v. Notice of Award of Contract; and the Bidder's conforme thereto; and
- vi. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the RFQs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
